- To ID ports, use different colored jacks for each application.



It should provide 2, 3, 4 or 6 ports which are field-configurable with a variety of simplex snap-in connectors/modules. It must have steel retainer nuts for the wallplate screws, and be constructed of high-impact, fire-retardant plastic rated UL 94V-0. Colors, configurations and related wallplates to be specified per schedule on plan. Must also be UL Listed, CSA Certified, and compliant with FCC Part 68 and TIA/EIA-568-B specifications. The manufacturer shall provide a one-year limited product warranty. The manufacturer shall provide a lifetime warranty against defects in material and workmanship and an application guarantee when installed as part of a certified system.


